Functions and Duties of Anti-Ragging Squad:

- The members of the squad will visit *at least once in a week* all potential areas of ragging in or outside of the college and hostel premises, including at night and may apprehend the culprits.
- The members must be vigilant at all hours including at odd hours all-round the campus and other places vulnerable to incidents of ragging and shall be empowered to inspect such places.
- The member must conduct anonymous random surveys among freshers to ensure that the campus is free from ragging.
- The members must conduct on-the-spot enquiry into any incident of ragging referred to it by the Head of the Institution or any member of the faculty, staff, student, parent or guardian or employee of a service provider or by any other person, as the case may be and the enquiry report along with the recommendations shall be submitted to the Anti-Ragging Committee for actions.
- The members must ensure the display of posters on the Institute notice boards and other prominent places.

Any one gets information about ragging or any other untoward activities must inform immediately to the members and it should be reported to the Anti-Ragging Committee.
