- The members must conduct anonymous random surveys among freshers to ensure that the campus is free from ragging.
- The members must conduct on-the-spot enquiry into any incident of ragging referred to it by the Head of the Institution or any members of the faculty, staff, student, parent or guardian or employee of a service provider or by any other person, as the case may be; and the enquiry report along with the recommendations shall be submitted to the Anti Ragging Committee for action.
- The members must ensure the display of posters on the institute notice boards and other prominent places.

Any one gets information about the ragging or any other untoward activities must inform immediately to the members and it should be reported to the Anti Ragging Committee.
